To advertise and introduce the "Borough of Dacorum (Off-street Parking Places) Order 2014" Traffic Regulation Order

Decision made and reasons:

To advertise and introduce the "Borough of Dacorum (Off-street Parking Places) Order 2014" Traffic Regulation Order.

The Order will introduce; changes to a number of car park tariffs, a change to a site designation, the power for the council to issue permits to park in car parks at its discretion, enforcement to bays designated for the use of electric vehicles, car club facilities in Wood Lane End car park and additional sites as agreed at Cabinet of 22 October 2013.

In line with the authority delegated to the Portfolio Holder at Cabinet and taking into account feedback from the formal consultation the following amendments are to be made:

- The proposal to introduce a four hour maximum stay in Langley Hill car park will not be pursued
- Amend the Traffic Regulation Order to facilitate tariff changes via Notice of Variation
- A number of bays in Water Gardens (South) car park are to be restricted to a maximum 30 minute stay
- Introduce the facility to issue season tickets in Durrants Hill car park (At the request of Hertfordshire county Council in support of planned changes at their Apsley centre)
- Introduce the facility to issue season tickets in Water Gardens (North) car park upper deck (At the request of Hertfordshire county Council in support of proposed construction works at South Hill School)

BACKGROUND

A review of parking arrangements in Dacorum has indicated that the town centre car park charges levied in the Borough remain competitive in comparison to the tariffs levied in privately owned car parks within the Borough and when compared to most other Hertfordshire and other local districts.

The Council faces significant challenges in producing a balanced budget over the next few years. Income from parking charges offers an opportunity for increased income particularly in view of the modest rates currently charged in comparison to other towns. Failure to optimise income would require Members to identify other opportunities for savings or income growth in order that the budget position can be addressed.

In policy terms the Council seeks to encourage greater thought regarding travel choice in line with the longer-term aim of seeing a shift to more sustainable forms of transport. Increased parking charges can certainly influence travel choices; however, the provision of viable alternatives, particularly for commuters, is a significant and costly challenge which will be difficult to address in the current financial climate.

The introduction of discretionary permits and the discontinuation of staff permits will simplify procedures for the issue of permits.

Following the acquisition of land in the vicinity of Dacorum Way the Order will enable enforcement of these areas.

The introduction of a 30 minute stay tariff in Water Gardens (South) car park will increase parking opportunities for customers wishing to use local facilities and is intended to support businesses in the town centre through the potential for increased footfall.

The introduction of electric vehicle Car Club bays in Wood Lane End car park will allow the council to test the viability of this type of initiative.

Electric vehicle points have been installed in The Forge, Canal Fields and Durrants Hill car parks, the Order will allow these bays to be restricted for the sole use of electric vehicles while charging.

The proposal to change the name of Civic Centre car park to Dacorum Way car park is intended to reduce any possible confusion to the council's customers after the relocation of premises in 2014.

Parking in Kings Langley and Markyate, and the first hour of parking in Tring and Boxmoor remains free to reflect the need to balance sustainable transport objectives against those of supporting the local economy.

At the Cabinet meeting of 22 October 2013 Members agreed parking tariffs for the financial years 2014 and 2015. It is these tariffs with amendments agreed by the Portfolio Holder that are to be advertised.
