## **Decision made and reasons:**

### **Decision:**

To delegate authority to the Assistant Director (Housing), in consultation with the Portfolio Holder For Housing, to award the contract for the scanning of single balconies and communal areas in relation to the Cantilever single balcony project.

#### Reason:

Where reinforcement is in the correct place, and therefore the balcony does not seem to require propping, the Council's structural engineer has still advised that not only should the outside section of all the balconies in the same block should be scanned, the inside should also be scanned to check that the reinforcement goes at least one metre within the building. The reason in part is due to an additional balcony collapse in April 2014 in Poole.

There are also communal areas that Building Control has asked to be scanned to make sure these have adequate reinforcement.

So as to carry out the work in a timely manner a company that specialises in concrete structures has been engaged. Due to the extra unforeseen works the scan cost could exceed £50k.

It is essential that there is no delay to this work for health and safety reasons and therefore it would not be appropriate to undertake a procurement exercise.
