THE BOROUGH OF DACORUM (CONTROLLED PARKING ZONES) ORDER 2021

NOTICE is hereby given that Dacorum Borough Council, pursuant to arrangements made with Hertfordshire County Council under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012, and in exercise of the powers conferred on that County Council under Sections 1, 2, 4, 45, 46, 47, 49, 51, 53 and 124 of the Road Traffic Regulation Act 1984, proposes to make the above mentioned Order, the general effect of which would be to:

- (a) provide the Ebberns Road Controlled Parking Zone (ZONE "E") in Ebberns Road by -
 - (i) providing a permit holder only (residents and residents' visitors) area in Ebberns Road between No. 120 Ebberns Road and Nos. 211 and 213 Ebberns Road, to operate between 9am and 6pm on Mondays to Fridays inclusive and between 10am and 1pm on Saturdays and Sundays inclusive;
 - (ii) providing permit holder only (residents and residents' visitors) parking bays in Ebberns Road between Durrants Hill Road and No. 120 Ebberns Road, to operate between 9am and 6pm on Mondays to Fridays inclusive and between 10am and 1pm on Saturdays and Sundays inclusive;
 - (iii) providing a goods vehicle loading bay on the south-west side of Ebberns Road outside Arabica House, to operate between 9am and 6pm on Mondays to Fridays inclusive and between 10am and 1pm on Saturdays and Sundays inclusive; and
 - (iv) introducing waiting restrictions to operate between 9am and 6pm on Mondays to Fridays inclusive and between 10am and 1pm on Saturdays and Sundays inclusive in Ebberns Road and extending to the extent of the public highway into Bridgeview Close and Lockview Court.
- (b) provide that the charge for permits (valid for 12 months) in respect of **Ebberns Road**Controlled Parking Zone and vouchers would be as follows
 - (i) £40 for the first resident's permit, £60 for the second and £80 for the third; (ii) no charge for a "blue badge" holder resident's permit if the holder is the vehicle's registered keeper; (iii) £20 for a motor cycle resident's permit and (iv) £5 for 25x 1 hour resident's visitor parking sessions, £3.25 for a 5 hour resident's visitor parking session and £4 for a weekly residents' visitors voucher (limited to 4 per year). (Note 1: a maximum of 600 hours of residents' visitors vouchers may be purchased in any year. Note 2: There is a 50% discount for Dacorum Card holders and applicants aged 60 years and over; and the same limits as above apply in terms of hours per year that may be purchased, except where the applicant is 60 years or over, where limits would be doubled)
- (c) provide that the properties that would now be eligible for permit issue in **Ebberns Road**Controlled Parking Zone would be:
 - (i) Nos. 1 to 9, 17 to 23, 33 to 45, 49 to 75, 103 to 211, 175a, 175b and 201a Ebberns Road (odds) and Nos. 2 to 12, 36 to 68, 72 to 86, 120 to 136 and 38a Ebberns Road (evens). (maximum of three vehicle permits per household); and
 - (ii) Nos. 163 to 183, 189 to 197 Lawn Lane (odds) and Nos. 182 to 206, 212 to 212, 224a, 224b and 226 to 226 Lawn Lane (evens) and Nos. 1 to 20 Belswains Green (maximum of one resident permit only these properties will not be eligible for visitor vouchers).
