Where have we got to?

Since the last public meeting in September, there has been a good deal of progress in a number of areas, and we have been speaking with everyone directly affected by the mine to try and make the final stages of the work as smooth as possible for all concerned. In particular, we have reached the stage of appointing a contractor to carry out the mine repair work itself: we are very pleased to offer the work to BAM Ritchies.

BAM Ritchies are highly experienced in this kind of work and have been involved in many major land stabilisation projects, including the Cross Rail project which is currently tunnelling under London. In particular, they worked with Welwyn Hatfield Borough Council to complete the successful repair of the chalk mine at Briars Lane in Hatfield, so are well versed in the kind of problems we face here.


They submitted an excellent bid which took into account the very precise needs of the Highbarns area, and had plenty of good ideas for minimising disruption for residents while the works are going on.

Plotting the mine

The first stage of the mine repair works was completed in June. This involved boring into the ground where the mine was expected to be – as indicated by previous surveys – to 'prove' its location and check its condition.

This work was carried out by Vinci, and they produced a detailed report in August, which Mark outlined at the last public meeting. The report showed that the mine was where it was expected to be and, importantly, did



not appear to extend beyond the edges of the land clearance area agreed with the Homes and Communities Agency. The full extent of the mine cannot be known for certain until the actual repair works are carried out, but the work done by Vinci was very positive in its results.

However, the work did show that more of the mine seems to have collapsed than expected. This is good because it means there are fewer of the open cavities which represent the greatest potential hazard, but not so good because it means more work is required; collapsed ground is harder to secure than open cavities. Even so, all the contractors who tended for the work outlined plans which should still enable the ground work to be finished by June, as planned.

Remediation works

Remediation work will not begin before Christmas. BAM Ritchies will draw up a timetable for each stage of the works and will agree with individual householders what needs to be done and when. Remember, the Council is only co-ordinating the work on your behalf and nothing will be done without your consent and approval.

During the tender process, several important aspects of the proposals were discussed, including:

- Scheduling of the work
- Flexibility over the time that properties need to be vacated
- Locating equipment and parking at a location outside of the Highbarns area to reduce the impact on residents' parking and other traffic
- Day-to-day availability for dealing with questions, concerns and problems as and when they arise
- Onsite security throughout the works
- Full and timely communications with residents

BAM Ritchies provided very clear and positive responses on each of these points.

Residents' Group meeting on 19 December

There is a meeting of the Residents Group at the Council offices on **19 December**. This will be the first opportunity for residents to discuss the above issues with the contractor.

How will you be affected?

BAM Ritches are planning to repair the mine in the simplest, quickest and most secure way possible. As soon as they can be certain about timings, they will let you know how you will be affected by the work. Heavy machinery will be needed but, as with the investigation works, everything will be returned to its original condition as soon as the works are completed.



The last on-site activity will involve checking that the work has been successful. BAM Ritchies will require access inside your

homes to ensure that stability has been achieved before certificates of assurance can be provided. Again, all the costs of this work have been budgeted for in the funding bid, and everything will be returned to normal once the tests have been completed.

Some properties will need to be vacated during the short period that work is undertaken underneath the premises. If you are affected, we will aim to give you notice one month before the work is due to start, but please note that in the early stages you may get shorter notice. We've been speaking with residents about what arrangements you are able to make, and what additional support we need to provide for those who have particular difficulties with temporarily relocating.

Removal costs and Insurance

Inevitably with this kind of work, there will be some risks to property. In the event that the contractors cause any damage, either through their actions or by neglecting to do something they should have, they'll be fully insured to cover those costs.

The cost of temporary removal, though, cannot be covered by the contractors, nor can it be met by the Council, as it would then be passed on to other Council Tax payers. Residents in the area have received reductions in Council Tax as compensation for the planning blight caused by the mine. If you do need to relocate temporarily during the works, your insurance company may cover the costs of this - but that depends on your insurance policy. Attached is a letter to insurance companies which is a formal statement that works will be necessary and costs may be incurred. Please let us know if you want further copies of this letter.

More information

We'll be publishing more newsletters until the project is completed. We'll also use local noticeboards and public events to keep you up to date, and we'll provide opportunities for you to ask any questions you may have.
